- 2. Fill in information for Setup New Account
- 3. Fill in Check Detail tab at the bottom of screen
- 4. Click on Add Access
- 5. Go back to login screen to login with your new user id and password
- 6. Click on 'I Accept' on the Terms with Service Agreement screen
- 7. If you wish to have your check stub detail automatically emailed to you each month, click on Owner Profile
- 8. Choose Check Detail Data under the Auto Send Options
