

### **ICCPR PROCESS: OVERVIEW**

**REPORT**: State submits a report under Article 40 of ICCPR

U.S. Fourth Periodic Report, 2011



• March 2013

**RESPONSE**: State delegation provides written responses to questions

• July 2013

**ADVOCACY:** Civil society submits "shadow reports" on issues mentioned in the questions or other human rights concerns. These reports are read by the committee to inform their questions and concluding observations

• Shadow Report, August 2013; lobbying up through final review, March 2014

**REVIEW**: State delegation comes before the Committee in Geneva for two days of questions. In the days before, civil society educates Committee members on human rights abuses, neglect, and misinformation

• March 2014 (originally October 2013)

**OBSERVATIONS:** Committee releases concluding observations a couple weeks after review

# ICCPR PROCESS: ADVOCACY







### **ICCPR PROCESS: ADVOCACY**

#### **UNEQUAL PAY**

 In 2012, women earned only \$0.77 on the male dollar. African American women make just \$0.68 and Hispanic or Latina women just \$0.59 for every dollar earned by a white man.

#### MINIMUM WAGE AND POVERTY

- Women make up 2/3 of minimum wage workers, and 4 in 10 are women of color.
- More than 70% of tipped servers are women, and their poverty rate is nearly 3 times higher than that for the general workforce (\$2.13/hour).
- Today, more than 4 in 10 female-headed families with children are poor.

#### **SEXUAL HARASSMENT**

 In 2011, it was reported that 1 in 4
American women had experienced workplace sexual harassment.


#### **DISPARITIES IN FAMILY LEAVE**

 The United States is one of the few countries in the world that does not offer paid maternity leave, although such programs do exist in the states of New Jersey, Rhode Island, and California.

#### **WORK-LIFE BALANCE**

- In 2011, 58% of women were in the labor force, and LF participation rate of mothers with children under 18 years of age was 71%.
- 40% of all households with children under the age of 18, the mother is the sole or primary income provider for the family, and of these breadwinner mothers, 63% are single.
- Quality child care is very expensive, costing low-income families up to 36% of their monthly income.
