If there are any changes to amount, date or frequency of your Direct Debit Lincolnshire & Nottinghamshire Air Ambulance Charitable Trust Ltd will notify you 10 working days in advance of your account being debited or as otherwise agreed. If you request Lincolnshire & Nottinghamshire Air Ambulance Charitable Trust Ltd to collect a payment, confirmation of the amount and date will be given to you at the time of the request.  
If an error is made in the payment of your Direct Debit, by Lincolnshire & Nottinghamshire Air Ambulance Charitable Trust or your bank or building society, you are entitled to a full and immediate refund of the amount paid from your bank or building society.  
- If you receive a refund you are not entitled to, you must pay it back when Lincolnshire & Nottinghamshire Air Ambulance Charitable Trust Ltd asks you to.  
You can cancel a Direct Debit at any time by simply contacting your bank or building society. Written confirmation may be required. Please also notify us.

- All customer funds intended for the use in future gambling and or lottery subscriptions will be held in a separate bank account or accounts relating to the relevant affiliated charity lottery and will be completely separate from the Charity's trading income.
- We are required by our licence to inform customers about what happens to funds which we hold on account for you, and the extent to which funds are protected in the event of insolvency.
