# Chairman's Update

Welcome to our spring newsletter for all residents of Wheal Regent Park from all of us serving on the board of Crinnis Wood Management Company.

I am happy to report that our Woodland has weathered the winter storms very well. We have lost two trees, one uprooted and the other with a broken canopy. These have been dealt with by our tree surgeon.

At the end of 2015 we had our bi-annual tree survey of the whole woodland. From this report, ten trees have been identified as requiring attention. Our managing agent, Christopher Anderson, has put this work out to tender and reported the results to the Board. It was agreed to place the work with Western Tree Services and they have completed the work.

The second year of our Woodland Management Plan is due to start as soon as weather permits, hopefully in early May.

As you have been advised, the plan is to work on several areas in the woodland each year. Making entry into the various areas takes time. As our budget for the work is modest, we must address the best use of time/funds. From the review of such work last year, Mr Anderson and our contractor, Paul Wallace, have been in discussions.

It is now proposed to tackle one large area and get the fallen timber gathered ready for removal. This area will be adjacent to the railway line, from the north east gate to the middle section of the woodland. When we have a start date, those members whose homes adjoin the site will be informed.

By 2017 we should have the phytophthora restrictions lifted and the timber removed from the woodland although we shall be in discussion with the Animal and Plant Health Agency to see if it is possible to lift the restriction on our central area sooner. In the autumn we hope to proceed to the areas already cleared beside Beach Road and complete further work there and continue our replanting scheme.

Western Tree Services have been on site for a few days taking down these trees, being mainly a mix of Scots Pines and Oaks. Western Power Distribution have cleared land under their overhead cables.

The saplings planted last year by Paul Wallace are growing well within the plastic tubes, we await them bursting out of the top. Several areas need clearing or burning of cut debris, any volunteers to assist would be welcome if a working party was formed.

We would welcome anyone who is fit and able to occasionally walk the woods.
