NHS ILLEGAL TOBBACO PROBLEM PROFILE

During the 3 months October 2012 throught to January 2013 we were very busy working on a commisioned piece of work for the NHS (the UK's National Health Service) namely a Problem Profile examining the impact of Illegal Tobacco on the South East region of the UK.

I can hear you asking the question why is a training company involved in such a piece of work. Well quite simply whilst our core business is eLearning we also undertake classroom work, and crime and intelligence consultancy. The problem profile fits under the latter and apart from anything else its nice to keep your hand in so to speak.

Researching, analysing and putting together the illegal tobacco problem profile was an interesting piece of work for us. We were of course aware of illegal tobacco before we commenced the work, both as ex-smokers and expolice officers. Nevertheless we learnt a number of things along the way. The first thing was the impact upon obtaining data and information of being outside law enforcement. When you are a cop with a sheriffs badge (same applies for civillian police staff) people in other organisations tend to want to help and if they don't you problem solve until you have what you need. As a civilian getting information is somewhat harder, even with interorganisational agreements in place.

The second thing of note that struck me was the scale of illegal tobacco. Its not some minor misdameanour that I naively thought it was; it is a massive international crime involving organised crime groups at all levels, from your low level local distriutors to transnational terrorists.

For the criminal illegal tobacco is a gift, low investment brings high rewards with less chance of being caught and less jail time if you are. The scarey thing about it, is that it doesn't even appear on the Police radar as an issue.

Tip: If you are involved in the investigation of crime and illegal tobacco features don't ignore it. Remember Al Capone didn't end up in prison for murder or bootlegging but for tax avoidance.
