TRUSTEES' REPORT For the year ended 31st March 2012

The Board of Trustees present herewith their report and the externally examined financial statement for the year ended 31st March 2012.

OUR ORGANISATION

The Eritrean Relief Association in United Kingdom has been registered as a UK charity and constituted as a company, limited by guarantee since 1988. ERA-UK has been operating and providing services as an unincorporated association since 1982. It is governed by a Memorandum of Articles of Association and the Board of Trustees is responsible for setting the strategic direction of the organisation for establishing policy. All Trustees and directors are not remunerated by the organization and possess managerial, professional and volunteering experience. The Trustees are appointed by the Board on the recommendation of other Directors.

ACHIEVEMENTS

In furtherance of our continued objectives, this year ERA-UK undertook:

- In partnership with regenerist Ltd ERA UK has successfully bid for £8,752 capacity building project funding from the Awards for All grant of the Big Lottery Funds. The project will be implemented during 2012.
- We have recruited and supported seven runners to take part in the British10K London Run in July 2011. The group raised a total of £4,831 (including Gift Aid) towards Bidho and Autism projects.
- ERA UK has supported a volunteer who took part in the Virgin Triathlon in September 2011, raising £208 for vulnerable children in Eritrea.
- Lewes dinner event in July 2011 raised £1160.00 towards vulnerable children.
- A festive season fundraising dinner held in December 2011 raised £639. This does not include three prizes worth £ £250.00 donated for the raffle on the day.
- Charity collection boxes at grocery shops and newsagents raised £431.
- As requested by our partners, National Bidho Association, ERA-UK acquired a variety of food items to supplement the needs of their beneficiaries. The cost was £7,202 excluding shipping costs (to be paid in 2013).
- A video camera with projector, glucometers, lancets and test strips were donated to our partners, the Eritrean National Diabetics Association, in accordance with their request. The overall cost including airfreight was £2,366.
- Capacity building assistance was provided to a PhD student from Southbank University who was doing a research on Eritrean history and food.
- A series of meetings and discussions with partners and visits to beneficiaries in Eritrea was carried out with our Trustee who was in Eritrea in January/February 2012. New partnerships requests were also presented to ERA-UK. These will be further discussed in the next financial year following ERA-UK Board consultation.

HOW WERE FUNDS SPENT?

Our funds this year were raised through the 10K sponsored runners in July 2011; through regular Direct Debit donations of supporters; a charity dinner by friends in Lewes, East Sussex; charity collection tins; and Gift Aid claims received from HMRC paid on behalf of UK taxpaying donors. We will also implementing the capacity building project supported by the Big Lottery Fund.

All purchases, shipping costs and services provided to our partner recipients in Eritrea, the National Bidho Association (for HIV/AIDS) and Eritrean National Diabetic Association was based in accordance to mutual consultation and in furtherance to their needs and requests.

All of the above mentioned partners have acknowledged receipt and provided letters of their appreciation. Their clear and transparent work delivered with passion and dedication drives us even more to continue our fund raising efforts to support them while they are in the process of developing vibrant, empowered, sustainable organisations and developing their eventual total self-reliance.

ERA-UK has no paid workers for its day to day running operations is therefore able to allocate 95% of all funds raised to go directly to target projects.

We appeal on your compassion to assist us by completing our Gift Aid form so that we may continue our work in Eritrea.

The Trustees have reviewed the major risks to which the charity organisation may be exposed and have taken the necessary steps to mitigate such eventualities.

STATEMENT OF TRUSTEE RESPONSIBILITIES

Company Law requires the Trustees to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the charity and of the profit and loss of the charity for that period. In preparing the financial statements, the Trustees are required to:

- Select suitable accounting policies and apply them consistently,
- Make judgments and estimates that are reasonable and prudent,
- State whether the policies adopted are in accordance with the Companies Act 1985 and with applicable accounting standards, subject to any material departures as explained in the financial statements;
- Prepare the financial statements on a going concern basis unless it is inappropriate to presume that the charity will continue in business.

The Trustees are responsible for keeping appropriate accounting records which disclose with reasonable accuracy at any time the financial position of the charity and to enable them to ensure that the financial statements comply with the Companies Act 1985.

The Trustees are also responsible for safe-guarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

ACCOUNTANT

Mr. Fitsum F Michael was appointed as the reporting accountant in accordance with Section 385 of the Companies Act 1985. Mr. Michael is fellow member of the Association of Chartered Certified Accountants and held senior offices at global accountancy practices and financial service organisations. No fee was charged by Mr. Michael for conducting the independent examination and reporting on the accounts.
