About The Fishermen's Mission

The Fishermen's Mission provides emergency and welfare assistance to active and retired commercial fishermen and their families through practical, spiritual and pastoral support. Every year we help thousands of beneficiaries, many in desperate circumstances.

Frontline operations are delivered through a network of full and part-time Port Staff, along with a number of volunteers that is spread around the coast of UK including Northern Ireland. The larger fishing ports have centres that provide basic domestic and recreational facilities, while others have welfare offices and some areas are covered by staff alone. The Port Staff is on-call 24/7 365 to respond to accidents and injuries at sea.

The operational staff are supported by a small Head Office team comprising the Chief Executive (who is also the Chief Operating Officer) and the Director of Business Development, with administration provided directly by the Executive PA, Senior Port Operations Administrator, and the Operations and Business team.

The Fundraising Team is responsible to the Director of Business Development and comprises of a Trusts and Legacy Manager, two full time Regional Fundraising Managers and one part time Regional Fundraising Manager. Port Staff also have fundraising targets.

PURPOSE OF JOB

To pro-actively increase the income raised from local communities, primarily in the defined geographic area, in a cost effective way, and in accordance with national income generation strategies and with strict adherence to the Institute of Fundraising Code of Conduct and the Fundraising Standards Regulator.

To recruit, motivate and retain volunteers and third parties to raise money for the Fishermen's Mission in the ways specified in the various strategies.

LOCAL PLAN

 To produce and work to a plan, to enable the successful attainment of all objectives required by the Director of Fundraising under the national fundraising strategy.

VOLUNTEERS

To recruit volunteers to assist you in this role

 To fully support national events such as 'Fish Friday' so that incomegenerating potential is realised directly and through the fundraising efforts of third parties and volunteers.

- To recruit and retain third party fundraisers, thereby increasing income.
