Privacy statement third party GDPR

Embassy Freight Services (UK) Ltd processes your personal data because you are using, or wish to use our services or because you have provided this information to us yourself.

WHICH DATA:

Embassy Freight Services (UK) Ltd collects data in order to provide you with the best possible service, or in order to comply with an agreement and / or to comply with legal obligations.

Embassy Freight Services (UK) Ltd may process your personal data, because you use the services of Embassy Freight Services (UK) Ltd, and / or because you provide it to Embassy Freight Services (UK) Ltd when you fill out a contact form on the website.

The following information is collected and processed by us:

E-mail address - Name & first name – Mobile number - Telephone number – Fax number – IP address

All data is processed in accordance with new European privacy legislation, the GDPR (General Data Protection Regulation).

PURPOSE:

This data will be used to communicate with customers, suppliers, partners and prospects in the context of the execution of our contractual agreement.

We also need this to answer any questions you have for us, in addition to the execution of your assignments.

We will also use this information to inform you further about services that are in line with the agreement we already have with you.

If no contractual agreement has been concluded, we will use your information to contact you, either by telephone and / or in writing (by email and / or by post). We will only do this with your permission.

If you have subscribed to our newsletter, Embassy Freight Services (UK) Ltd will use your contact details for sending you their newsletter.

STORAGE:

In a contractual context, Embassy Freight Services (UK) Ltd does not store your personal data longer than strictly necessary and / or legally required to realize the purpose for which your data is collected. In any case, your data will not be stored longer than the legally prescribed terms.

SECURITY:

Embassy Freight Services (UK) Ltd has taken sufficient technical and organizational measures to ensure the safe processing of your personal data. These measures correspond to the nature of the personal data, are proportionate to the potential severity of the risk, and serve to prevent misuse, loss, unauthorized access, unwanted disclosure and unauthorized modification.

The Embassy Freight Services (UK) Ltd website uses a reliable SSL Certificate to ensure that your personal data does not fall into the wrong hands.

The risk of accidental or unauthorized destruction, loss, modification or access to and any other unauthorized processing of the data has been minimized. Unfortunately, no risk can be completely avoided. In case of unauthorized access to the IT systems of Embassy Freight Services (UK) Ltd, we will immediately take all possible measures to minimize the damage to and / or theft of the data. If the rights of the involved party have been violated, a notification of data leak will be made to the Privacy Commission as well as to the involved party.

TRANSFER OF DATA:

Embassy Freight Services (UK) Ltd will only transfer your personal information to third parties (within the EU or outside the EU) when this is strictly necessary in order to execute our agreement, or in order to comply with legal obligations. You can object to this at any time.

If Embassy Freight Services (UK) Ltd uses external parties, partners or subcontractors, they will also need to comply with the new regulations. Embassy Freight Services (UK) Ltd will arrange for an agreement so the required safety measures are taken and how these can be checked.

COOKIES:

When visiting our website, we will store the general information in our site registers (including the IP address from your computer, the time when the search request was made and the information your browser provides). Embassy Freight Services (UK) Ltd uses this information to optimize the website. We try to anonymize this data as much we can.

In case you notice that other cookies are being displayed on the screen, please inform us immediately so we can take the necessary steps to modify our site.

GOOGLE ANALYTICS:

Embassy Freight Services (UK) Ltd uses Google Analytics to track how users use the website and how effective the AdWords Freight Adwords ads on Google are.

The information obtained, including the address of your computer (IP address), is transmitted to and stored by Google on servers in the United States.

Google uses this information to keep track of how our website is used, to provide reports on the website to Embassy Freight Services (UK) Ltd and to provide its advertisers with information about the effectiveness of their campaigns.

Google may provide this information to third parties if Google is legally obliged to do so, or insofar as these third parties process the information on behalf of Google. Embassy Freight Services (UK) Ltd has no influence on this.
