SightCare and its associated companies are registered as Data Controllers with the Information Commissioner. SightCare is the Data Controller for the purposes of collecting your information on our Forms and any services we offer via your SightCare Membership.



#### 1. What personal information is collected from you

When you join SightCare we collect various personal information which may include your name, practice address, practice contact details, personal contact details, staff practice contact details. When you visit our websites we collect various personal information which may include your name, address, contact details, IP address, and information regarding what pages are accessed and when. If you purchase a product from us, your card information is collected by our partner organisation, PayPal, but is not held by us. If you supply such information we are legally bound by the Data Protection Act 1998.

#### 2. How your information is used

We may use this information in the following ways:

- To inform you about the services we provide;
- To process orders submitted by you;
- To carry out our obligations arising from any contracts entered into by you and us;
- To verify your identity;
- To seek your views or comments on the services we provide;
- To notify you of changes to our services;
- To improve our services or marketing purposes;
- To send you communications which you have requested and that may be of interest to you.

These may include information about products and services and promotions of our associated companies' goods and services.

#### 3. Who has access to your information

We are committed to protecting the personal data of our members and customers. Any details you give us will be held in accordance with the Data Protection Act 1998. SightCare (including its associated and subsidiary companies) is the sole owner of the information collected on its Forms. We will not sell, share, or rent this information to third parties, unless we have your explicit permission to do so, or we are required to do so by law, for example, by a court order or for the purposes of prevention of fraud or other crime. Where you have given us permission we may contact you about other services and products or pass your details to similar organisations.

When you are using our secure online payment pages, your payment is processed by PayPal, who specialise in the secure online capture and processing of credit/debit card transactions. If you have any questions regarding secure transactions, email the webmanager (<u>www.paypal.co.uk/uk</u>)

We may transfer your personal information to a third party as part of a sale of some or all of our business and assets to any third party or as part of any business restructuring or reorganisation, or if we are under a duty to disclose or share your personal data in order to comply with any legal obligation or to enforce or apply our terms of use or to protect the rights, property or safety of our members and customers. However, we will take steps with the aim of ensuring that your privacy rights continue to be protected.



#### 4. How you can access, update or delete your information

### 5. Security precautions in place to protect the loss, misuse or alteration of your information

When you give us personal information, we take steps to ensure that it is treated securely. Any sensitive information (such as credit or debit card details) is encrypted and protected with the following software 128 Bit encryption on SSL.

When you are on a secure page, a lock icon will appear on the bottom of web browsers such as Microsoft Internet Explorer.

Non-sensitive details (your email address etc.) are transmitted normally over the Internet, and this can never be guaranteed to be 100% secure. As a result, while we strive to protect your personal information, SightCare cannot guarantee the security of any information you transmit to us, and you do so at your own risk.

Once we receive your information, we make our best effort to ensure its security on our systems. Where we have given (or where you have chosen) a password which enables you to access certain parts of our websites, you are responsible for keeping this password confidential. We ask you not to share your password with anyone.
