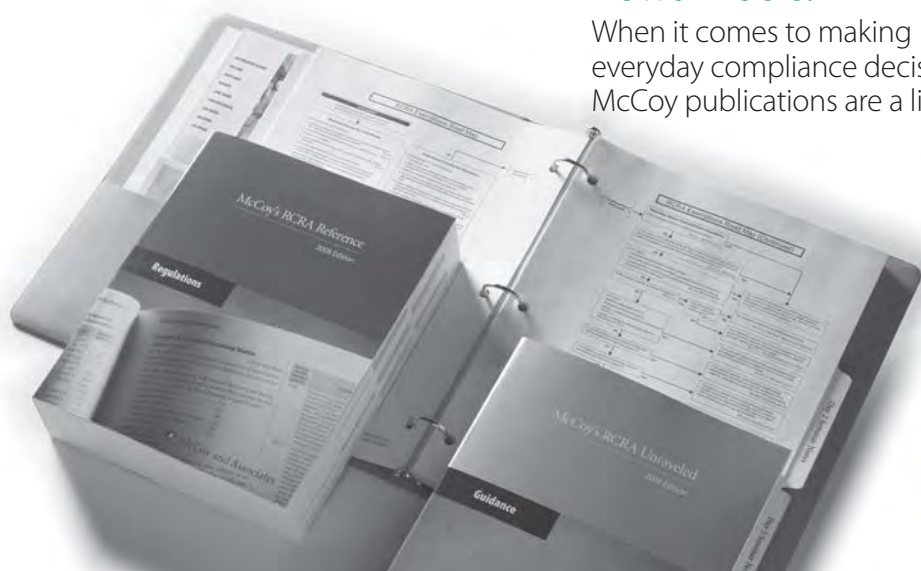

**DAY 1: RCRA Fundamentals** The basis of RCRA compliance is to know, with certainty, whether or not your waste is hazardous. On Day 1 we present a structured methodology for determining if wastes are hazardous and, if so, what waste code (or codes) apply. We'll help you understand how EPA defines "solid waste" and "hazardous waste." You'll learn how to identify various types of characteristic wastes and listed wastes, how spent solvents are regulated, and how mixtures and treatment residues are regulated. But the most important things you'll learn are what questions to ask and how to use *RCRA Reference* and *RCRA Unraveled* to find the information you need.

**DAY 2: Critical Generator Issues** We'll help you understand the rules you have to comply with if you generate hazardous waste. We'll cover the key RCRA requirements for both small and large quantity generators and provide you with practical guidance on how to comply. Major topics include waste counting, satellite and 90/180-day accumulation, and recordkeeping. You'll also learn how the major exclusions and exemptions work and how to manage special types of hazardous waste, such as universal wastes, electronic wastes, aerosol cans, and solvent-contaminated wipes. **Note: the topic of "Manifesting" is now on Day 4.**

**DAY 3: Advanced RCRA Topics** On Day 3, we'll clarify some of the more complicated aspects of the hazardous waste regs. For example, we'll explain how "treatment" is defined and show you eight ways you can treat hazardous wastes without obtaining a RCRA permit. We'll teach you how to determine if a material that will be recycled is a "solid waste." We'll also discuss the top ten most common RCRA violations and how to avoid them. Other topics include sampling, used oil management, and the most important things you need to know about hazardous waste tanks, surface impoundments, and waste piles.

**DAY 4: Air Emissions, Manifesting, and Land Disposal Restrictions** We continue our discussion of advanced RCRA topics with a presentation on the RCRA air emission standards in Subparts AA, BB, and CC. We'll also cover the hazardous waste manifest requirements. Then, we turn to the land disposal restrictions (LDR). Understanding this important part of the regulations is critical if you want the big picture on hazardous waste management in this country today. We'll present step-by-step procedures for LDR compliance. We'll explain how the treatment standards work, when you need to identify underlying hazardous constituents, and how to fill out the paperwork. We've also added a module on how to prepare for a RCRA inspection.

**DAY 5: Remediation, Demolition, and Spills** During the half-day program (we adjourn at noon) on Day 5, we cover corrective action, the contained-in policy, and remediation waste management. We'll explain how spills and spill residues are regulated and what you need to consider when managing debris from demolition projects. We'll also provide a concise summary of the changes that have occurred in RCRA in the last two years and give you a preview of how RCRA may change in the next few years.
