



Relationship: Facility Review

Getting the full picture. What risk looks like, and how we can mitigate it

We begin the process by gaining a complete understanding of the facility, the processes and strategies, and the critical touchpoints for risk. We discuss any specific concerns management and staff have about high-risk situations, the efficacy of the products currently being using, and what 'reducing risk' looks like. We then conduct an on-site review of all anti-ligature fittings and fixtures that have been installed to doors and washrooms and assess them against the following criteria \rightarrow

Once the review has been undertaken and the data has been analyzed, we will submit a formal, comprehensive evaluation report to the facility's management for review.





At the end of this workshop we will have clearly specified which anti-ligature products will work for the facilities owned by the company, and how these will be rolled out.






