Category 1 applicants

If you are renewing an existing ACS or OFTEC qualification, you are considered to be a Category 1 applicant.

Training prior to undertaking assessment is not mandatory, however in most cases it is recommended to ensure that operatives are aware of the most recent changes to legislation, British Standards and industry best practice. It should be noted that attendance for training will not influence the independent impartial assessment which is carried out under the control of a recognised certification body.
