- 1. Meeting was called to order at 7:23a.m. by President Bob Sadler due to printing issues.
- 2. Motion was made by Chris, seconded by Jason, to approve the Agenda as presented. All Aye. Carried.
- 3. Motion was made by Cathy, seconded by Gail, to approve August minutes as written. All Aye. Carried.
- 4. Motion to approve July and August financials was made by Cam, seconded by Jason. All Aye. Carried.
- 5. Sandy advised there is a lock box at Kerndt Brothers Bank that she cannot find the key for. That was previously Community Development's lock box. It is \$200 to drill out. Board gave suggestions of who was on that board for her to check with before having to drill.
- 6. Amie and Nick gave an update on the Pocket Park. Council approved the purchase of the lot from Norm Einck at \$7,000. Sandy will request a concept drawing from Main Street to put on a sign so it is aware that the lot remains for sale.
- 7. West Union Cares group has decided to disband, and asked if we would take over the Easter Basket Hunt. Bob advised his 4-H group would actually like to do it. Decided to partner together on the event. Motion was made by Amie, seconded by Chris, to approve the partnership. All Aye. Carried.
- 8. Discussed sharing our email list, and what is the right thing to do. Sandy said a lot of people that are not investors have been asking her to send fliers and info out via email. After some discussion, it was decided to have the email sent to Sandy and then she will forward if it is a current investor. Motion was then made by Gail, seconded by Amie to charge \$50 for each time to non-investors. All Aye. Carried.
- 9. In doing the abstract work on the sale of the lot in Commercial Court, Bob was advised he would need to update all abstracts due to our organization being West Union Main Street and not Chamber. For \$100, he could reinstate the Chamber name for the real estate. All agreed that was the best way to proceed. Motion was made by Chris, seconded by Cam, to approve the reinstatement of West Union Chamber. All Aye. Carried.
