The last year has been exceptional from a bilateral trade perspective as the volume of business and investment between the UK and Israel continues to grow with total bilateral trade now up to \$5.8bn. 2014 saw a record year of Israeli companies listing on London Stock Exchange, with more Israeli companies listing than from any other country excluding the UK.

For UK Israel Business, the breadth and depth of our relationships is key and in addition to our regular events, we create new connections for our members on a daily basis. Whether assisting UK corporates in their search for the latest in Israeli innovation or working with members on their Israeli marketing initiatives, we make appropriate and meaningful introductions. After a meteoric rise through the Ministerial ranks following his election in 2010, Sajid Javid was appointed Business Secretary in May 2015. # The Rt Hon Sajid Javid MP

Secretary of State for Business, Innovation and Skills



The Rt Hon Sajid Javid MP was appointed Secretary of State for Business, Innovation and Skills on 11 May 2015. Prior to this, he was Secretary of State for Culture, Media and Sport from April 2014 to May 2015, and has held posts as both the Economic and Financial Secretary to the Treasury. He is the MP for Bromsgrove.

Sajid has been the Member of Parliament for Bromsgrove constituency since being elected in the 2010 General Election. He was a member of the Work and Pensions Select Committee from June to November 2010 and joined the Conservative Party in 1988.

Before being elected MP, he worked in business and finance. The son of a bus driver, he attended state schools before winning a place at Exeter University to study Economics and Politics. Aged 25, he became a Vice President at Chase Manhattan Bank and later moved to Deutsche Bank in London to help build its business in emerging market countries. Sajid left Deutsche Bank as a senior Managing Director in the summer of 2009 to give something back through politics.

As Secretary of State, he is responsible for strategy and policy across the Department for Business, Innovation & Skills (BIS), which covers everything from business law to consumer issues, trade policy, further education, skills and innovation. As lead Cabinet Minister for reducing the regulatory burden across government, he is also President of the Board of Trade and holds overall responsibility for the BIS budget.

# Lifetime Achievement Award

Sir Harry Solomon



Sir Harry Solomon began his career as a solicitor in the 1960s, and founded the law firm Solomon Taylor  $\vartheta$  Shaw in 1984.

In 1976 he co-founded Hillsdown Holdings plc, where he was Chairman and Chief Executive, and which became one of the largest food groups in Europe – supplying a wide variety of foods to leading supermarkets. Hillsdown had an annual turnover of over £3bn and employed over 50,000 people. In 1991, he was knighted for services to the food industry.

During his time at Hillsdown Holdings, Sir Harry forged business dealings with Israel, including joint ventures with a number of Israeli companies in the food sector.

Following his resignation as Chairman of Hillsdown, Sir Harry has been a director and investor in an array of public and private businesses in the UK, USA and Israel, particularly in the Israeli hi tech industry.

He co-founded and is Deputy Chairman of The Portland Trust, which through offices in London, Tel Aviv and Ramallah is committed to promoting peace and stability between Israelis and Palestinians through economic development. In Israel, The Portland Trust is heavily involved in efforts to reduce poverty in the periphery, and is helping to develop a social capital market in Israel, introducing some of the financial instruments and tools developed in the UK.

Sir Harry has also been at the forefront of efforts to promote ethnic and economic integration in the Western Galilee region. This part of Israel comprises Jews, Muslims, Christians and Druze and is where 43% of Israel's small communities, including half the Kibbutzim in Israel, live. Sir Harry has been involved in a number of philanthropic projects in this area, including founding The Solomon Family Clinic. Last year The Sir Harry Solomon School of Management opened at The Western Galilee College in Akko, where he is Chairman of the Trustees. The School will train the next generation of Israeli managers, from all ethnic backgrounds, to lead the public sector, civil society and business, enhancing the area's competitiveness in the national and global economy.

After decades of business activities with Israel and philanthropic funding of education and co-existence initiatives to better Israeli society, Sir Harry Solomon is a truly worthy recipient of the Lifetime Achievement Award 2015.

Since launching routes to Israel in Nov 2009, easyJet has increased its number of flight routes to Tel Aviv to include London Gatwick, Paris and shortly Amsterdam over 2014/2015. As a result, the low-cost carrier will fly more than half a million passengers a year into and out of Ben Gurion on 37 weekly departures to Amsterdam, London (Gatwick), London (Luton), Manchester, Geneva, Basel, Rome, Milan, Berlin, and Paris.

#### Ladbrokes

The creation of Ladbrokes Israel, as a subsidiary of Ladbrokes International, in May 2013, saw the expansion of its digital business through a partnership with Playtech. As part of this deal, Playtech will provide e-Commerce and digital marketing services, as well as supporting its gaming product through its IMS software. To staff the new office, Ladbrokes Israel also acquired 40 senior-managers from The Nation Traffic, a highly experienced online and offline CRM company to work with Playtech's products and back office systems.

#### **Shop Direct**

# Shop Direct, the UK's leading multi-brand online retailer, started working with the Israeli tech-scene in 2011 after forging a partnership with programmatic display company, MyThings. They have run several start-up sourcing sessions in Israel and as a result, in 2014, Shop Direct formed commercial agreements with two Israeli e-Commerce start-ups, Cimagine and yRuler. They are currently in trials with more than 6 Israeli tech businesses, including Cabara and Namogoo, and recently announced a major partnership with Tel Aviv-based media company Kenshoo to manage their Google and Facebook marketing.

Over the past year, Cimagine together with Shop Direct (a leading UK online retailer), has implemented the largest deployment of Augmented Reality (AR) for retail to date. Chosen by Microsoft and Coca-Cola Bridge as one of Israel's most promising start-ups, Cimagine is taking AR in retail to the next level.

#### **MyCheck**



MyCheck is a technology platform that pairs the ability for a restaurant's customers to 'check-in' and pay using their mobile. It also incorporates the ability for restaurants to rollout customised loyalty schemes using analytics and business intelligence to inform their users' mobile experience. MyCheck's clients already include Busaba Eatha and Prezzo in the UK and recently it closed a Series B round of \$5m with Santander Innoventures Fund as the lead investor.

#### Zeek

Zeek is a mobile application that helps consumers sell their unwanted gift vouchers and store credits to other consumers who are interested in them, at a discount. Having experienced rapid growth within Israel, Zeek launched in the UK in December 2014 and is aggressively building its business out of London - growing to over 100,000 regular users in a year. In May 2015, Zeek announced that it had secured \$3 million in Series A funding from Blumberg Capital, Qualcomm Incorporated, through its venture investment group, Qualcomm Ventures and Waze founder/existing investor and Chairman, Uri Levine.

Plus500 is a Trading Platform enabled clients to trade on movements in the price of shares, indices, commodities and forex, without having to buy or sell the underlying instrument. In July 2013, Plus500 completed its IPO, raising \$75m on London's AIM, valuing the company at \$200m.

Established in 2007 the Group is a leader in advanced payment technologies. In March 2014, SafeCharge completed its IPO in London on AIM, raising \$126m, valuing the company at \$404m.

After listing in London in 2005, Telit's revenue soared in 2014, with its UK business revenue tripling to \$9.3m from \$2.9m and a successful acquisition of ATOP, an automotive grade solution for vehicle manufacturers. Maintaining its R&D centre in Israel, its unique combination of products and services feed data directly into applications and business IT systems to deliver realtime intelligence to businesses across industries.

### **XLMedia**



XLMedia is an online performance marketing company that attracts paying users from multiple online and mobile channels and directs them to online businesses such as gambling and social gaming businesses. It works under performance based business models, with over 50% of its revenues from recurring revenue share agreements. With fast growing business segments in publishing (owning 2,000 informational websites in 18 languages), self-funded digital media campaigns and management of its partner network, XLMedia has established itself as a high-growth company, raising \$69.4m on London's Aim in March 2014, valuing company at \$154.2m.


