Wavereley Hotel BAR & GRILL Term & Conditions

Please read the following most carefully

- 1. Once the original enquiry has been made please phone to make an appointment in order to view the hotels facilities. This will give us the opportunity to check your preferred date and answer any initial questions, a provisional enquiry will only be held for 4 weeks.
- 2. The selected date would then require confirmation. This will be secured upon receipt of a deposit of £50.00inc.VAT for each function, and completion of the confirmation form.
- 3. In the unlikely event of a cancellation, for whatever reason or circumstance, deposits are totally nonrefundable.
- 4. If the Booking is cancelled all deposits are non refundable.
- 5. If cancelled with more than 28 days notice 50% of booking required if cancelled within 28 day 100% of booking required

Note: It is advisable to take out an Insurance Policy to cover any unlikely eventuality.

- 6. The menu, final arrangements and approximate numbers attending will be finalised by appointment with the hotels Wedding/Function co-ordinator one month prior to the function we will call you to arrange a mutually convenient date for this meeting.
- 7. Final numbers must be notified to the co-ordinator 7 days prior to the function, this confirmed number will be the minimum charged.
- 8. Full and final payment must be made 7 days before the event. Any additional expenses incurred on the day will be invoiced for payment within 7 days of the reception or settled upon departure.
- 9. The room hire charge is £150.00 if no catering required.
- 10. Entertainment equipment may be brought into the building subject to discussion and agreement with our Function & Event Co-ordinator. Any electrical equipment must have a valid Portable Appliance Test Certificate. Any entertainment equipment or facilities required to be hired for Social events will be organised and managed by the Trust's Catering Provider who will invoice the Hirer for all such equipment and facilities hired.
- 11. The Hirer will be held responsible for any damages or loss of furniture, equipment or crockery. The Hirer shall pay to the Waverely Hotel, on demand, the amount required to make good or remedy any such damage.
- 12. A refundable damage bond of £100 will be charged for Evening events with entertainment in addition to the prices quoted. This will be refunded in full subject to there being no damage to the Wavereley Hotel property or equipment.
- 13. In accordance with the Waverely Hotel Licence the maximum capacity of the function room is 130 persons seated at tables and chairs or 175 persons seated/dancing including all performers, technicians and caterers.
- 14. In accordance with legislation, no smoking is permitted anywhere within the Waverley Hotel.
- 15. The Waverley Hotel BAR & GRILL reserve the right to confiscate any alcohol being consumed on the premises which has not been purchased from the Waverley hotel BAR & GRILL.
