6:15pm Session 1 – Caroline Gregory, Cyber Account Executive at Vantage Professional Risks

With Data Protection Regulations due to change in May 2018, GDPR forces all organisations to ensure that the way in which they handle their data is in line with the regulations, and the consequences of not complying. This presentation will advise on the requirements under GDPR and how charities, who are particularly vulnerable due to the nature and volume of sensitive data they hold, can ensure that they are taking the necessary steps to safeguard the data they hold.

Caroline has been analysing risks to businesses for a number of years, having previously worked as a Lloyds Underwriter specialising in cyber and professional indemnity insurance.
