#### **Welfare Reforms**

At one of its best attended events over 60 groups attended the Hastings Community Network conference on the Welfare Reform changes.



The aim of the event was to ensure that groups were briefed on the changes and could begin to discuss how best to create a strong community network of support to those affected by them.

The event discussed a wide range of issues from access to affordable loans, food-banks, advice, energy costs, furniture and emergency items.

The report of the conference will be fed into a local group led by HBC which will be taking forward actions at a local level.

The event also welcomed the Community Organisers and heard about their work engaging with local people.

#### **Foreshore Trust Small Grants**

A new source of funding has been established by the Hastings & St Leonards Foreshore Charitable Trust (the Charity) for Community Groups in Hastings and St Leonards specifically to fund events on the Foreshore.

The Charity will be offering grants up to £2,000 to local organisations, with a total of £20,000 available in the first round of allocations.

In addition there will be a further round of the Foreshore Trust Small Grants fund. As in previous rounds the Charity will be offering grants of up to £5,000 to local charitable and voluntary community organisations, with a total of £50,000 available.

Information on how to apply for both programmes will be available via the HVA and HBC websites from Friday 3rd May 2013. The deadline for applications for both funds will be 12pm on Thursday 30th May 2013.

# **Shaping Hastings – The Planning Strategy**

Following the Hearing sessions as part of the Examination in Public, the Council is now proposing some "Main Modifications" to the Planning Strategy.

These are needed to ensure the Plan is found "Sound" and "Legally Compliant" and can proceed towards adoption. We are also considering the implications of the recent revocation of the South East Plan and the latest population projections.

It is important that local communities and other stakeholders are also given the opportunity to consider these changes and whether they have an impact on policies in the Planning Strategy.

We will therefore be undertaking further consultation during May/June 2013, where you can submit your comments to be passed onto the independent Planning Inspector.
