# DON'T FALL FOUL OF PAYROLL RULES AND REGULATIONS

Payroll has changed rapidly over the past few years with the introduction of real time submissions to HMRC and more recently Auto Enrolment.

We have tried to give our clients as much information and guidance along the way as possible and more and more are asking us to take away the 'Payroll headache' and look after this side of their business for them.

Focusing on Auto Enrolment, if you still haven't started the journey to implementing an appropriate pension scheme then below are some key points that you need to bear in mind;

- Even if don't have a PAYE scheme but you still employ staff i.e. because the employees earn below the lower earnings limit, you will still have to adhere to Auto Enrolment rules which will apply from 1st April 2017.
- Director only companies who have more than one Director may still have Auto Enrolment duties.
- Companies who set up a PAYE Scheme from April 2012 onwards will have a staging date between May 2017 & February 2018.
- New PAYE Schemes from March 2018 onwards will automatically stage at the point the scheme is set up.
- If your company uses self-employed workers, there is a possibility Auto Enrolment may still apply to you.

Once the company has staged the Employer will have Auto Enrolment duties to carry out, the following is a list which some or all will apply;

- ✓ Setup a pension scheme with a reputable provider
- ✓ Regulatory communications to employee's / staff
- ✓ Assess workers 'eligibility' each pay period
- √ Manage opt-in/out requests
- ✓ Calculate any pension contributions due
- ✓ Monitor and communicate pension details to any new workers
- ✓ Option to postpone the staging date up to 3 months
- ✓ Declaration of Compliance
- Reporting to the chosen pension provider
- √ Re-enrolment duties every 3 years



The Government have set regulatory minimum contributions that are required to be paid into your chosen pension scheme, these are;

Failure to comply with auto-enrolment duties may result in penalties as follows:

# TAX ENQUIRY INSURANCE SCHEME

In February 2017 we will be mailing all our clients inviting them to join/renew the tax enquiry insurance scheme.

Sources indicate that HM Revenue and Customs will be targeting more small-medium sized businesses to improve compliance therefore we can expect to see an increase in the volume of HMRC enquiries/ compliance checks. Answering all of HMRC's questions takes time and the enquiries often drag on for months and sometimes take years to conclude. It can cost thousands of pounds to defend you, whatever the end result. The insurance will cover the professional fees incurred in the event of an HMRC enquiry/compliance check therefore giving you peace of mind that no additional accountancy costs will be payable by you directly.

Please note that we need all declarations and premiums payable by 1st April 2017 so act quickly when the letter drops through your letterbox!

# DIRECTORS AND OTHERS ON 'MINIMUM' SALARY 2017/18

It has been announced in the Autumn Statement that anyone who is currently being paid a salary of £670 per month (or £155 per week) in order to secure National Insurance Contributions will have an increase to £680 per month (or £157 per week) from 6 April 2017.

# LATE TAX RETURNS

#### 31st January deadline is fast approaching.

HMRC will charge an initial penalty of £100 if your tax return is filed late.

This will apply regardless of whether there is any tax liability – previously if there was no liability or all tax had been paid by the due date, there was no penalty.

Additional penalties will be charged as follows:

- Over 3 months late a £10 daily penalty up to a maximum of £900
- Over 6 months late the higher of £300 or 5% of the tax shown on the return
- Over 12 months late a further £300 or a further 5% of the tax due (whichever is the higher). In particularly serious cases the penalty can be up to 100% of the tax due.

#### Late payment of tax

For payments due on 31 January HMRC will charge the following penalties if tax is paid late:

- A 5% penalty if the tax due on 31 January is not paid within 30 days (the 'penalty date')
- A further 5% penalty if the tax due on 31 January is not paid within 5 months of the penalty date (i.e. by 31 July)
- Additionally, there will be a third 5% penalty if the tax due on 31 January is not paid within 11 months of the penalty date (i.e. by the following 31 January).

These 'late payment' penalties are in addition to the interest that is charged on all outstanding amounts, including unpaid penalties, from due date to date of payment.

#### **EMAILS SCAMS - PLEASE BE AWARE!**

There are email scams that are circulating at the moment that are supposedly from Companies House and HMRC.

The most recent Companies House email that we received states that there is a complaint that has been submitted to their Web Filing Service and to open the attached document which we can only presume would have a virus attached to this. This is sent from

noreply@companieshouses.com it has the Companies House logo and address on the footer of the email.

When receiving an email from HMRC please be careful this will be a scam as HMRC do not send emails out regarding refunds or tax that is owed to them. The most recent email that we received from HMRC was from do.not.reply@rice.edu and stated that we were due a tax repayment and

to click the link to 'submit the tax refund request'. The link would have gone to another page that asked for confidential bank details which the scammers could use to scam you out of a large amount of money.

Please be careful and do not open any emails from Companies House or HMRC if you are unsure please contact the office.

#### TYG TRIAL

#### **NEW CANCER VACCINE**

Stopfords client TYG Oncology Ltd have signed an agreement with Cancer Research UK to trial its new antigen-specific, active checkpoint control cancer vaccine TYG100, in cancer patients with advanced solid tumours.

TYG100 is among a range of new treatments that use a patient's own immune system to target hormones that encourage the growth and spread of solid tumours. It works by triggering the production of antibodies that specifically target two members of the gastrin hormone family that help to fuel tumour growth.

Fred Jacobs, Director of TYG, commented on this great achievement: "We are very pleased to be working in partnership with the clinical experience and expertise from Cancer Research UK to advance TYG100. Cancer Research UK's sponsorship of the Phase I clinical trial is a significant technical and financial validation of our novel therapeutic vaccine. TYG100 will be attacking some of the most difficult and deadliest solid tumours, including pancreatic and gastro-oesophageal cancers."
