SPRING HARVEST 2018 HARROGATE: TERMS AND CONDITIONS

1. Your Booking

- Bookings can be made online at www.springharvest.org or by telephone at 01825 769000.
- All bookings should include a responsible adult who is at least 19 years of age.
- A non-refundable deposit of 20% of the booking fee is needed to secure your booking.
 - The full cost may be paid, if you wish, at the time of booking. The balance is due by 1 February 2018. Staged payments are possible, by arrangement with the Spring Harvest office. Any bookings not paid in full by 2 February may be cancelled by us.
- Full payment is required for any bookings made after 1 February 2018.
- <u>A contract</u> will come into existence between you and Essential Christian when we accept your deposit payment and issue an email confirmation of your booking.
- The contract binds you and all members of your party. The contract lasts until you and your party leave the event. It is your responsibility to ensure that all members of your party accept the terms and conditions of reservation and the provisions contained in these 'Terms & Conditions'. Failure to disclose all relevant information or comply with these terms may lead to termination of the contract and loss of the booking.
- The person making the booking must attend the event in Harrogate.
- The person making the booking remains the contact point for the booking.
- <u>Your ticket</u>. In February and once we have received your payment in full, Essential Christian will send you a ticket by email that will include all booking information. You will need to print it and present it on arrival.

Your ticket remains the property of Essential Christian and may be withdrawn and admission refused at any time.

- If bookings are made and the confirmation email is then returned to us as 'unknown email' and we cannot contact you by phone or receive a reply to a letter requesting a correct email address, we reserve the right to cancel the order and retain a £10 admin fee.
- Neither the venue nor Essential Christian shall have any further liability beyond the face value of the ticket purchased.

Those who have been, or remain on the Sex Offenders Register will not be allowed to attend Spring Harvest.

2. Prices

3. Concessions

• Spring Harvest operate concession schemes for people in financial hardship. Funds are limited and are awarded on a first come, first served basis – subject to conditions and the availability of funds.

4. Accommodation

You are responsible for arranging your own overnight accommodation. Information given on the website is provided to assist you find suitable accommodation. Spring Harvest has not made an assessment of the accommodation and the inclusion of information is not a recommendation.

5. Guests with a disability

- Spring Harvest is committed to making its events as accessible as possible: please contact us for more details regarding venues, BSL interpreting and other services. Please note that strobe lighting may be used.
- If you have special requirements, please let us know at the time of booking. We will do our best to meet these requirements but they cannot always be guaranteed. In particular, please tell us if you use a wheelchair or mobility scooter.

 For reasons of health and safety Spring Harvest team members are advised not to lift any buggies or wheelchairs. Spring Harvest can accept no liability for any form of damage or loss suffered by wheelchair users if team members help with mobility.

6. Amendments to your booking and cancellations

Amendments

 Many amendments, including adding new people to your party, can be made through a link to our website in your confirmation email.

Cancellations

- As soon as you know that you need to cancel, call the Customer Services team on 01825 769000 or email info@springharvest.org.
- Cancellations must be confirmed in writing. Charges will be made for cancelled bookings.

Cancellation charges:

- Cancellation charges are calculated from the date your instructions are received by our Customer Care team. If
 you cancel by phone, you must confirm the cancellation in writing either by post to
 Spring Harvest, 14 Horsted Square, Uckfield, TN22 1QG or by email to info@springharvest.org before any refund
 will be made.
- Any refunds payable will be made via the original payment method:
 - Bookings cancelled before 1st February 2018 will lose their deposit.
 - If a booking is cancelled 2nd February 1st March 2018, Spring Harvest will retain half the booking cost. There will be no refund for bookings cancelled after 2nd March 2018.

Transfers

If you are unable to attend after making a booking, you may transfer your booking to another person or family and the price will remain the price it would have been at the time of your booking. **However** the following conditions must be followed:

- This will be a private arrangement between yourselves; we will not refund your deposit
- Details of the new booker must be sent in writing to the Spring Harvest office otherwise you will remain responsible for payment of the balance.
- Guests will not be admitted to the event if they are not named on our booking system so Spring Harvest must be notified in writing of all name changes.

Insurance

You may be able to buy insurance to cover yourself against cancellation due to illness, accident or other unforeseen circumstances, but we are unable to recommend any such insurance.

If we cancel your booking

Should it be necessary for us to cancel your booking, we will refund your payment.

7. Identification Requirements and Data Protection.

- All guests aged 18 or over are required to provide identification on request. The only accepted forms of identification are a photographic driver's license or passport (provisional licenses are also accepted). Failure to provide identification if asked may lead to refusal of entry.
- In addition, for every person making a booking we must have the full name, full postal address, including postcode, phone number and email address, and for each additional person on the booking. We must have a full name, so that we can keep you informed of arrangements and so that we know the identity of all guests, to help to provide an environment that is safe and secure for all.
- You must inform other members in your party of the information about them that you are providing to us, and what we will use it for. For the purposes of data protection the person who makes the booking is the representative of all members of their party. You may choose to provide us with information about your health or the health of members in your party so we can assist you with any disability needs. This information will only be used for the purpose(s) for which you provide it to us.
- Essential Christian will use your information to communicate with you in advance about the Spring Harvest event and to inform you about other events and products from Essential Christian. If you do not wish to receive such information please contact the Marketing Manager, Spring Harvest, 14 Horsted Square, Uckfield, East Sussex, TN22 1QG.

8. The Event

• Before you arrive please ensure that we have the names of every member of your booking and contact details of the person making the booking. If names on your booking don't match the guests who arrive we may cancel your booking and you will forfeit your payment.

• <u>Timings</u>:

Arrival time: Entry on Tuesday 3rd April is from 2pm.

Programme finishes at 11.30am on Saturday 7th April

Wristbands will be issued to guests who are named on a booking at check-in and must be worn at all times during the event.

- Guests without wristbands will be refused entry to venues and may be required to leave.
- Should you lose your wristband, please go to the Spring Harvest Information Point.

Health and Safety

- The right to admission is reserved by Essential Christian and the event venue, who may take health and safety, environmental and security concerns into account at their discretion, and may carry out security searches including bag searches.
- We would advise you that no refunds will be offered to customers who are refused entry or ejected on account of
 abusive threatening, drunken or other anti-social behaviour (including smoking in no smoking areas), carrying
 offensive weapons or illegal substances, declining to be searched or making unauthorised audio, video or
 photographic recordings in restricted areas.
- Should we become aware, or have reasonable grounds for suspicion, that a guest has contracted a contagious
 disease that has the potential to infect a large number of people quickly, they and their party will be required to
 leave.

Children:

- Spring Harvest will do everything we can to provide children with a safe and caring environment. Full details of our Safeguarding Policy are available on request.
- Children remain the responsibility of parents or guardians at all times. Except when registered in the appropriate Spring Harvest programme sessions, children aged 11 years and under may not be left alone without full adult supervision.

 Your attendance at Spring Harvest implies permission for us, and agencies authorised by us, to reproduce your image, likeness and voice on or in albums, publicity material, television and radio broadcasts – including online. This may include circulation outside the UK.

Pets:

• Pets are not permitted in the Centre. Assistance dogs are accepted by prior agreement.

Programme:

- Programme information and updates will be shown on the Spring Harvest website.
- Changes to the programme or the withdrawal of certain facilities, may be made if necessary.
- No unauthorised trading or leafleting is permitted within the Centre.
