Free Early Education Entitlement (FEEE)

Some 2 year olds are entitled to free early education from the term after they are 2 years old. This entitlement equates to 15 hours per week spread over 38 weeks (570 hours per annum) when taken during school term time. These hours are provided free of charge.

All 3 year olds are entitled to 570 hours of free early education per annum from the term after they are 3 years old. This can either be taken 15 hours per week spread over 38 weeks, when taken during school term time, or 11 hours per week when spread over 52 weeks per annum. We offer both options at our settings, please see full details of the options below. These hours are provided free of charge. You will be charged and invoiced for any hours or services that you wish to purchase that are above the free entitlement.

NOTE: parents/carers who only wish to take up their FEEE hours only, do not incur any monthly payable fees, unless you wish to purchase nursery meals, extra hours or extra-curricular activities.

You may be entitled to the extended entitlement for working families. This can either be taken 30 hours per week spread over 38 weeks, when taken during school term time or 22 hours per week when spread over the 52 weeks per annum. We offer both options at our settings, please see full details of the options below. These hours are provided free of charge. You will be charged/invoiced for any hours or services that you wish to purchase that are above the free entitlement.

Delivery options

Free Early Education only

1. 2, 3 & 4 year old children who only want to take up their Free Early Education Entitlement (FEEE) to 15 hours per week (there is no option to purchase additional hours with this option)

Places can only be taken up over 38 weeks per annum during school term time between 9am and 12pm (3 hours) for 5 days per week in our settings; The Valley Centre places are available from 1pm to 4pm (3 hours) for 5 days per week.

2. Children who are eligible for the extended working family Free Early Education Entitlement (FEEE) who wish to take up their free hours only can take them up over 38 weeks per year. There is no option to purchase additional hours with this option- this is only currently available at the Higham Hill Centre.

Places can only be taken up over 38 weeks per annum. Between 9am and 12pm (3 hours) and 1pm to 4pm (3 hours) for 5 days per week.

Additional charges are payable for the following services for families **only taking up their FEEE and not purchasing any additional hours**, please speak to the centre manager for further information and availability. Extra-curricular activities such as optional trips may have an additional charge depending on the activity, and a daily charge of £8.40 for breakfast, lunch and afternoon snack.

Free Early Education with additional hours purchased

Please see below the fees from 1st April 2019 for children who are entitled to free hours under the Government's Free Early Education Entitlement (FEEE) scheme but wish to purchase additional hours.

The annual entitlement is stretched over 52 weeks and equates to 11 hours per week for families entitled to the 15 hour entitlement and 22 hours per week for families entitled to the extended working families offer. This pro-rated basis on the hours attended.
