INTRODUCTION FROM CHARLIE RIGBY

FOUNDER AND CEO, THE CHALLENGER TRUST

At The Challenger Trust we have the privilege of helping young people to make new beginnings. The personal development programmes we are asked to commission, and the individual expeditions we fund, enable young people who face many personal challenges to reach their potential outside the classroom environment.

The Challenger Multi-Academy Trust (CMAT) was approved in 2014 as a sponsor of English state schools. CMAT will grow to 12-20 schools in which we shall develop the 'Challenger' model. This is a supportive environment for study where honesty, character and fair play are highly valued and the Challenger Diploma an integral part of improving standards and achieving academic success.

I truly believe that if young people embrace challenges, perhaps learning a new sport, musical instrument or attempting the local dialect in a foreign country, in the long-term they can expect excellence. All of these things teach failure, the ability to try again and the ultimately rewarding feeling of mastering something – an important lesson whatever stage of life you are at.

The Challenger Trust works collaboratively in disadvantaged communities to raise achievement, improve behaviour, reduce exclusions, increase attendance and

improve staying in learning rates and over the past 16 years we

have helped over 40,000 young people. We supported and delivered for the National Citizen Service in 2013, and are working extensively with deprived children in Nottingham alongside the L.E.A.D. Academy Trust and Nottingham City Council.

Unfortunately, there are many more young people at risk of social or economic exclusion than we currently have funds to reach.

THE NEED

The successful work of The Challenger Trust is needed now more than ever.

- The Secretary of State for Education has put an emphasis on the building of character and has issued quidance on promoting British values in schools, the effectiveness of which will be judged by Ofsted. Inspection criteria will include personal development, behaviour and welfare.*
- The CBI stated in December 2014 that "employers are clear that a successful education system is one which equips young people with the attitudes, behaviours and characteristics that are needed for success in a work environment - determination, resilience, creativity and emotional intelligence, for example - are a crucial part of the picture that employers want to see as a key focus in schools".
- One in seven young people in the UK is not in education, employment or training (NEET) at great personal cost to them and to society. The number of 16-24 year olds classed as NEET is steadily declining at 13.1% in the third quarter of 2014** but this is still well outside the target of 10%.



"Nearly one million young people are 'NEET' and the number of children **at risk** of becoming NEET has failed to decline. We therefore work with children as young as eight years old. The proven learning outcomes of our outdoor education programmes are both educational and behavioural." CHARLIE RIGBY

Our innovative projects and progressive courses give those at risk of becoming NEET alternative pathways to success.

The role of The Challenger Trust is to commission, fund and evaluate. We use outdoor education to bring about lasting impact but we are not a provider of courses. Neither are we an adventure holiday company.

Our vision is that all young people should have the opportunity to maximise their potential through outdoor learning. We therefore work to:

- deliver the best outdoor educational training in the field
- ensure every project is unique and a highly customised experience
- supply evidence of tangible outcomes and lasting impact
- continue to be a small organisation with minimal overheads

- 'My Journey': life's expedition model for recording and learning from progress
- Employability what needs to be added to exams to make someone employable
- Focus on attributes not skills





CASE STUDY: THE JACK PETCHEY FOUNDATION PROJECT

1000 young people from seven London Boroughs, including Waltham Forest, Islington, Camden, Southwark, Hackney, Lambeth and Greenwich took part in five day residentials with a strong focus on the Duke of Edinburgh Award Scheme.


