Information we collect

The personal data that you choose to share with IAG when requesting a quote for a product on our website will be Name, DOB, Address, Email and Phone Number, Insurance requirements.

This information is not stored in a database on the website. Any submission via website will be sent to enguires@insuranceadvisorygroup.co.uk.

When visiting our website, we will also automatically collect information about your browser, device e.g. (Tablet, Mobile, Desktop) and your IP address.

We don't collect any information from children or sensitive data.

How will we use your personal information?

Personal information supplied by you on the website will be used for the purpose specified in the privacy policy or relevant parts of the website:

- Administer and assist you with your quotes, policies
- Send you details of policies purchased through our website and supply services purchased for IAG
- Inform you of products and services that may better meet your needs
- Improve your browsing experience
- Send you general (non-marketing) commercial communications
- Provide third parties with information to gain quotes

Our lawful basis for processing is legitimate interests. It is in the legitimate interest of the user to be introduced to an FCA authorised adviser in order to fulfil their request for a quote. This is balanced with our business grounds for facilitating this introduction. The user's rights are respected and upheld always.



Providing information to third parties

Insurance Advisory Group Ltd will not sell, trade or rent your information for direct marketing.

We will never disclose information about you to third parties, except to fulfil your needs. For example, when you take out an Insurance policy provided by a third party, they will need your details to administer the policy or claims.

Also, if you choose to spread the cost of your insurance over the year, your payment details will be passed to a third-party company providing your insurance. IAG use third party websites for the purposes of price comparison, these may be websites operated by insurers, general agents or price comparison sites.

We may disclose information about you to the extent that we are required to do so by law.

Security of your personal data

We will take reasonable organisational precautions to prevent the loss, misuse or alteration of your personal information. We will store all personal information you provide on our secure server. All information sent or received by IAG will be encrypted using SSL technology.

Web forms are sent via HTTP, so are not encrypted much like email. For this reason, we do not require sensitive information to be sent on any form.

Your personal data rights

Under data laws known as GDPR you are in control of your personal data. Specifically, you have the following rights:

- Right to delete/remove data
- Right of access to all personal data processed
- Right to correct data
- Right to restrict our use of personal data
- Right to object

How long do we keep your personal information?
