Christine Weller, Council Member

1) Asked the City Manager if the problem that was reported at the last Council meeting was taken care of regarding debris along River Avenue at Castle Co-Packers. Mr. Gray reported that Ann Powell has been in contact with management at Castle Co-Packers and the Complainant. Mr. Gray stated that it had been cleaned up and organized.

Deputy Mayor Gerry Baldonieri

1) Asked the City Manager what the status is with the radio tower bid. Mr. Gray advised that the bid was advertised in the Latrobe Bulletin and we are waiting to receive those bids.

NEW BUSINESS

Deputy Mayor Baldonieri asked if anybody inquired about the Fourth of July Committee, Chief Sleasman advised that he spoke with Carol and nobody has approached her at the present time. Council Member Weller announced that she would like to see Isaac McDanial from the Banana Split Committee get involved with the Fourth of July, although, Mrs. Weller could not confirm if he would be interested.

Council Member Forish announced that Carol approached the Fire Department about taking over the Fourth of July, Mr. Forish along with Chief Brasile stated that the Fire Department has not yet decided on taking over the committee.

OPEN FORUM FOR CITIZENS' REQUEST

Cassondra McCune from 509 Main Street spoke about what the City Police Department is going to do about speeding vehicles on Main Street. Chief Sleasman advised that the Police Department is actively ticketing motorist who are speeding and performed traffic enforcement throughout the City.

Douglas Sterrett from 1010 Alexandria Street spoke about removing a no parking sign in front of his residence that is never enforced. Mr. Gray responded that he will be discussing this issue along with other complaints regarding parking along that block at the next agenda meeting. Mr. Sterrett also spoke about removing the traffic signals on Ligonier Street from Chestnut Street to Weldon Street as all they do is waste your time sitting in them. Mr. Gray advised that next year all the traffic signals in the Downtown Business District will be replaced and properly timed to reduce the congestion that currently takes place.

CITY MANAGER'S REPORT

Advised that he submitted the 2019 Automated Red-Light Enforcement (ARLE)
Grant. This grant will be used to install electronic flashing school zone speed limit warning devices along Lincoln Avenue, Cedar Street, and Ligonier Street.
