## 2. COMPOSITION / INFORMATION ON INGREDIENTS

Between 20 - 25%: Anionic surfactant Xn: R36; S25-26-46

#### 3. HARZARDS IDENTIFICATION

Irritating to eyes.

#### 4. FIRST AID MEASURES
