



# Terms of Website Use

Please read these terms of use carefully before you start to use our site. By using our site, you indicate that you accept these terms of use and that you agree to abide by them. If you do not agree to these terms of use, please refrain from using our site.

## 1. Information about us

**1.1** [www.mixologygroup.co.uk](http://www.mixologygroup.co.uk) is a site operated by Mixology Limited ("we"). We are registered in England and Wales under company number 07386517 and have our registered office at Mixology Ltd, 84 Western Road, Lewes, East Sussex, BN7 1RP. ## 2. Accessing our site

**2.1** Access to our site is permitted on a temporary basis, and we reserve the right to withdraw or amend the services we provide on our site without notice (see below). We will not be liable if for any reason our site is unavailable at any time or for any period.

**6.1.2.6** loss of goodwill;

**6.1.2.7** wasted management or office time; and for any other loss or damage of any kind, however arising and whether caused by tort (including negligence), breach of contract or otherwise, even if foreseeable.
