- INITIAL REPORTING —

The Safety Media Incident Reporting module allows any employee to log into your learning management system, and fill out an Incident Report form securely online.

They can report upon:

- » Injuries
- » Near Misses / Dangerous Occurrences
- » Damage to Property / Assets
- » Breaches of Security

Supporting evidence such as photographs, forms etc can be added to the report & location / date information is stored within the system.

MANAGEMENT OF THE INCIDENT —

Once submitted the relevant people are informed via automated notifications.

They will be able to log into the system, view the report and fill in additional details; such as:

- » Adding actions to be taken
- » Resolving actions taken already
- » Attaching further documentation
- » Triggering a RIDDOR notification
- » Cost analysis: time and financial

Once all of the above has been completed and actions closed off, the Incident Report can be filed and considered complete.



DASHBOARDS -

This allows stakeholders to analyse trends, identify hot-spots, manage areas for concern and other information relevant to making decisions allowing for a safer working environment.



OUR SOLUTION

Within the Enterprise portal, you can create Audit templates which can be distributed for completion by relevant managers - for example Store Managers in retail units.

Upon completing an audit form, the designated person will be able to review each criteria, attach relevant documents and assign a pass / fail status based on particular criteria.

The solution is currently used widely in retail, hospitality and leisure chains to ensure the managers are keeping stores and locations safe for staff and customers alike.



ACCOUNTABILITY

Audits can be assigned to users with a cycle for completion. Should audits not be carried out on time, automatic alerts can be sent through the reporting hierarchy so that disciplinary action can be taken.

FOR EXAMPLE...

If a Store Manager doesn't complete their audit on time, then the Regional Manager will be informed, if this continues then the relevant Director will be informed and so on throughout the reporting hierarchy.



You can now send out your IT policy or Health & Safety policy to all new starters and they will have to digitally acknowledge that they have read and understood the information within.

This is a much more robust form of policy distribution as your organisation will benefit from a digital audit trail showing acceptance and understanding, should the need ever arise.

No more web radio being played on work computers and users pleading ignorance to having seen the IT policy - now you can prove not only that they have seen it but when.











DOF SUBSEA A PERMIT TO WORK

Safety Media have collaborated with DOF Subsea to create a best practice compliance course titled "Permit to Work" designed to help promote safe working cultures and ultimately save lives.

DOF Subsea employ staff globally in a number of unusual environments ranging from vessels, dive systems, remote operated underwater vehicles and offices.

In these diverse conditions Health & Safety concerns are of paramount importance. Since creating this course, the relationship between Safety Media and DOF has gone from strength to strength.

THE PROBLEM -

The Permit to Work Scheme is a technical measure document demonstrating competence in situations to avoid major accidents. It ensures employees have the right qualifications for undertaking certain tasks and makes everyone working on a job aware of everyone else's participation and roles.

The staff at DOF are multi-lingual and based all over the world covering 24/7 shift patterns and so emphasis was placed on the need to find an appropriate solution to demonstrate competence.

THE SOLUTION —

Due to the technical nature of the content this was provided in the main part by the team at DOF Subsea. The Safety Media content team then took this information and made it come alive following best practice and various Instructional Design guidelines. We even sent a team to spend a day on board the Skandi Aker, DOF's Flagship vessel, to film footage to be used in the course.

TECHNICAL INFORMATION ABOUT THE LEARNING MANAGEMENT SYSTEM.

—— SYSTEM SECURITY —

Safety Media recognise the importance of data security and resilience and this is built into our system at every level. Our developers are directly employed by Safety Media Limited and undertake regular training and reviews to ensure that security plays a key role in the development life-cycle.

Our customers benefit from a clear and robust commitment to maintain our obligations in data processing and to act always in accordance with the General Data Protection Regulations.

Our customer application and database servers are hosted with AMAZON WEB SERVICES (AWS) specifically within EU regions so that there is no transfer of data outside of the EU. Each Environment is held within an Amazon Virtual Private Cloud (VPC) solution which provisions a logically isolated section of the AWS cloud. Replication is also handled within an isolated VPC solution.

Safety Media make use of AWS VPC security using security groups as a firewall to control traffic at the instance level and also network access control lists to control traffic at subnet level. Access keys are issued only to approved personnel and are reviewed and reissued on a regular basis to maintain security. AWS also enables the **FLEXIBILITY** to be able to provide specifically configured temporary access keys should these be required for specific operations.

The system is protected by an SSL CERTIFICATE and passwords are not stored as plain text.

Our application has been **PENETRATION TESTED** by NCC Group who are global experts in cyber security and risk mitigation and vulnerability scans commissioned via NCC Group which form part of the Quality Assurance sign off process for every update.

We are also **COMMITTED TO SYSTEM RESILIENCE** and business continuity at Safety Media. Through our use of AWS we're able to maintain a solution which is scalable to demand and has multiple fail-over mechanisms built for continuity of service should there be an issue with any part of the environment. Our continuity and recovery plans are regularly tested to ensure that these mechanisms will work should they be required.

CONTENT DELIVERY NETWORK —

As part of our commitment to providing excellent user experience, we have devised a way to store all data in a robust way and deliver fast access to rich content.

All of our e-Learning courses are hosted by AWS in a cloud server based Content Delivery Network (CDN).

A Content Delivery Network can deliver content rapidly around the world - giving your audience a local-like experience, no matter how far they are from your origin server.

It works by caching content at global edge locations, so that when users want to view your content, they can receive it quickly from the nearest server in the CDN. The content is refreshed once our courses are renewed so you can be sure that all of your users are seeing the most up to date courses at all times.

API WEB SERVICES.



INTRODUCTION TO API

The API Web Service presents a set of services in order to facilitate data exchange between a third-party platform and the Safety Media Learning Management System ("LMS"). What this means in simple terms is that the API allows our LMS to talk to other databases such as your HR, CRM systems etc.

The benefit of this for you is that employee data can be pulled directly from your current data management system into the LMS to allow records to be managed centrally and updated automatically. Less data entry = less work and less room for errors.

To see if your systems will work with our API we have included some technical information to share with your IT department, however, if you have any queries or require more information please contact your account manager or sales@safetymedia.co.uk.

- TECHNOLOGIES & DEPENDENCIES —

The API makes use of the following key technologies, which are required in order for integration to be achieved.

SOAP WEB SERVICES

The API is exposed as a SOAP web service.

SOAP METHODS

SOAP web services contain one or more web service methods. The term 'web service' is used to describe both a collection of methods and a method on its own.

HTTPS

SOAP uses HTTPS in order to transmit messages.

ΧМΙ

The messages transmitted to/by SOAP web services over HTTPS are serialised in XML format.

The XML represents a structure of data required for, or generated by, the web service.

Internet

The API uses HTTPS over the Internet.

An understanding of HTTPS and developing Internetbased applications is required to implement the API.

The API will be accessed as a HTTPS resource.

----- API WEB SERVICES

The API presents the following services:

LMS USER MANAGEMENT

This web service is for managing LMS users. The operations provide user management functionality such as adding and updating users, assigning users to departments, and resetting passwords.

LMS TRAINING MANAGEMENT

You can control all training plan operations from the Training management web service. This allows you to keep human interaction with regards to course allocation and user assignment to a minimum.

LMS DATA FEED

Retrieve training records / status from the LMS via the Data Feed web service and obtain completed, incomplete and overdue training information to help fulfill external reporting on employee activities.

SINGLE SIGN ON



WHAT IS SINGLE SIGN ON?

Single Sign-On (SSO) is when a user logs-in once to an application (the user signs-on), and in doing so gains access to other applications (such as the Safety Media LMS) without being prompted to log-in again at each of them.

The application the user first logs-in to is sometimes referred to as an Identity Provider or Identity Authority. The other applications are sometimes referred to as Service Providers.

HOW IS IT USED?

The benefit of single sign-on is that your users will not need to log-in to the LMS. Instead, your users will log-in once to your web-portal / intranet, Windows desktop or other type of application, and then gain access to the LMS by clicking on a portal menu-link, or a desktop shortcut.

To your users, they will seamlessly log-in to the LMS without having to type in their username and password.

In reality the menu-link or the desktop shortcut starts the single sign-on process between applications, for that user.

HOW WILL IT WORK?

- 1 THE USER...
 - a) signs-on to your software portal; or
 - b) logs-in to a Windows desktop PC.
- 2 THE USER EITHER...
 - a) clicks a portal menu-link to the LMS, which takes the user to your single sign-on software module; or
 - b) visits the LMS directly, which talks back to your software module.
- 3 Your single sign-on software module will formulate a message / instruction and send it to the LMS single sign-on software module.
- 4 The LMS single sign-on software module will interpret the message in order to determine the user for whom access should be permitted.
- 5 The LMS will attempt to authenticate the user. This is performed using a look-up/map between the customer remote user and LMS local user account (prior-created).
- 6 If the user has an LMS account they are logged-in to the LMS.

WHAT ARE THE TECHNICAL REQUIREMENTS?

To establish a trust between your software and the LMS, you will need to implement or develop a software module for formulating messages/instructions and transmitting them to the LMS. It must be to the SAML 2.0 specification. If you operate a Microsoft Windows network then you can implement a Microsoft Active Directory Federation Service. This would effectively be your software module. This would be the case for on-premise / cloud networks e.g. ADFS 3.0, Azure, AD Connect. The LMS must know about the users your software is instructing it to allow access for. The users must be added to the LMS to create Local User Accounts. For automation, the local LMS users may be created via a web service.
