1. <u>Declarations of Interest.</u>

2. Minutes of the last meeting.

These were agreed to be an accurate record and were duly signed by the Chair.

- 3. Matters arising.
 - Item 9a) Streetscene, Bettisfield.

Cllr. Blanchard and Clerk had emailed the Canal and River Trust to raise issues of car parking near to, and dog fouling along the canal. Both had received acknowledgement, but no further information. Clerk to email again to remind CART of the issues.

• Item 9b) Streetscene, Penley.

Trees are causing damage to garage rooves at Penda's Park, Penley and also to the perimeter fencing. Clerk to contact WCBC to request that they cut back the trees, as they would appear to be growing on council land.

Drainage problem in Penley has been reported, but no action taken. Clerk to report again.

• Item 11a) Village Projects, Bettisfield.

With reference to the suggestion that a joint project between MSCC and CART could install a fitness trail near the canal, a request for a meeting had been received from Ani Sutton of CART. Bettisfield councillors will follow this up.

Cllr. Mrs. Coathupe-Fox had scrutinised bank statements and reported that all was in order.

5. <u>County Council matters.</u>

No report was received.

6. Open Forum.

The council were asked to support an application by The Rainbow Centre, Penley, for a Together in Wrexham 'Enabling Grant'. If successful, the grant will be used to establish A Digital Inclusion Project via a Community Internet Access Point. There were no objections and the application was countersigned by the Chair on behalf of the council.

7. Penley Playground.

In the absence of Cllr. Mrs. Coathupe-Fox, this item will be deferred until the next meeting.

8. Website.

Cllr. Ms. D. Kettle reported that the website was not easy to update and that she intended to spend some time with Cllr. Coathupe-Fox to learn how to update information. Cllr. Gurr asked for access so that he could look at the problems.

9. Streetscene

- a) Bettisfield.
 - The Vehicle Activated Sign continues to work well at both ends of the village.
 - Clerk to contact Streetscene again regarding the Cadney/Cadney Lane signpost.
- The signpost on the A495 at Bettisfield is damaged. Clerk to report to Highways.
- b) Penley
 - A mattress has been fly-tipped near to New House Farm in Hampton Wood Road. Clerk asked to contact Shropshire Count Council to request its removal.

- a) Bettisfield
 - Fitness Trail Councillors to meet with Ani Sutton of CART.
- b) Penley
 - Wasteland near to the hospital has been cleared. Mr. G. Williams will establish
 the condition of the ground and assess what might be done there. A poster has
 been displayed to canvass public opinion. A spring gate will be put in and better
 fencing erected to ensure safety.
 - Clerk to establish who owns the woodland behind Hillcrest, Penley and write to request permission for MSCC to make the area safe and possibly install a fitness trail.

12. Meetings attended by councillors.

Cllr. Mrs. Sime attended the Wrexham LAG meeting. It was reported that projects were coming in well. The question of what would happen to funding if the UK left the European Union was raised. The Welsh Government has pledged to make up the shortfall until 2020.
