- Necessary for the purposes of legitimate interests pursued by the controller or a third party, except where such interests are overridden by the interests, rights or freedoms of the candidate.
- To ensure the right to work in the UK/EU of the candidate.
- To establish suitability to the role/s being applied for on behalf of our clients to provide the service levels agreed.
- To establish information in regard to what the candidate is seeking when applying for roles we are working on.

Any legitimate interests pursued by us, or third parties we use, are as follows:
