# The Arc of Texas Committees

### Ad Hoc Bylaws Committee:

The Bylaws Committee is responsible for the creation and maintenance of the organization's bylaws, which is the set of rules that guide its operations and activities.

### Ad Hoc Chapter Services Committee:

The Chapter Services Committee maintains a regular system of communication with local chapters including the Annual Chapter Meeting and Conference, and also monitors issues impacting local chapters and members and makes recommendations to The Arc of Texas Board about those issues

#### **Board Development Committee:**

The Board Development Committee ("BDC") takes into account a variety of factors in selecting candidates to be nominated to the Board of Directors of The Arc of Texas. Every year, the BDC reviews the current composition of the board, considers future needs and sets priorities for the current nominating cycle.

#### **Executive Committee:**

## Public Policy & Advocacy Committee:

The Public Policy & Advocacy Committee, in conjunction with staff and local chapter input, develops policy priorities, implements advocacy plans and crafts legislative strategies that create positive change and meaningful outcomes for people with intellectual and developmental disabilities.

### Revenue Development + Programs Subcommittee:

The Revenue Development Committee develops and recommends philanthropy and fund development policies to the Board.
