Go Green Adventure Camping Association

Farmer and Landowners. Membership Terms and Conditions

The following Terms and Conditions shall apply to all agreements between JW Leisure Ltd., and Farmers and Landowners (FLO) Members of the Go Green Adventure Camping Association (GGAC-A) :-

1. The FLO agrees to join the GGAC-A and for the details of their camping Venue to be displayed on the GGAC website, subject to approval of the FLO.

2. JWL does not guarantee any Bookings but undertakes to attract as many as possible. Campers are free to make their own choice.

3. As at the 20th August 2015 and until further notice, no joining Fee is payable.

4. Membership of the GGAC-A is continuous until either party decides to cancel a Membership.

5. To ensure continuous Membership of the GGAC-A, it is a condition that, unless a separate

agreement is made, the FLO Member only accepts campers introduced by JWL. Failure to comply with this may result in the Membership being cancelled and removal of the Venue from the GGAC website.

6. The Classification awarded to the Venue can be varied by JWL, either up or down.

7. The GGAC-A Member agrees to accept campers during the camping season (or longer if agreed) from Easter or the 1st April (whichever is earliest) for a minimum of either one or two nights up to a maximum of fourteen nights. If there are any nights when a Venue cannot accept campers,

GGAC should be advised, at least 14 days in advance, to enable the excluded date/s to be shown on the Venue Webpage.

8. The FLO shall ensure that there is in place adequate insurance (including but not limited to Public Liability insurance) and that they will not do anything to invalidate the insurance. The FLO is responsible for all applicable safety and regulatory standards required for their land to be used as a Venue for camping.

9. The FLO is expected to provide the facilities specified by the FLO on the JWL Questionnaire and the FLO agrees to indemnify JWL against any claim arising from the non-availability of specified facilities.
10. JWL will be responsible for dealing with all Bookings, including collection of camping fees. JWL will pay the FLO direct, into the FLO's specified Bank account, 70% of the camping fees within five working days of the paid Booking being received. In the case of Shepherd Huts, Yurts, Bell Tents and Camping Pods, owned by the Venue, 75% of the camping fees will be paid to the Venue within five working days of receipt of the paid Booking.

11. In dealing with camping Bookings, JWL makes every effort to avoid refunds (pleased note the procedure for dealing with refunds set out on the GGAC web page "Making a Booking"). In the event of a refund having to be made, the FLO agrees to refund the fee for the particular Booking within 48 hours to JWL. On receipt, JWL will make the refund to the camper in accordance with the procedure as mentioned above. It is important that this is done expeditiously to maintain the good will and good name of GGAC and its Members.

12. Save for death or personal injury caused by its negligence or the negligence of its employees, JWL does not accept any liability for any loss , damage, costs, expenses or any other claims arising out of, or in connection, with a camping Booking. All warranties, conditions and other terms implied by statute or common law are, to the fullest extent permitted by law, excluded from the agreement.

13. These Terms and conditions shall be governed by, and construed, in accordance with the Laws of England. Any disputes shall be the subject to the exclusive jurisdiction of the Courts of England.
