## **PRIVACY POLICY**

#### **BACKGROUND:**

Taktika Business Solutions Ltd (TBS) understands that your privacy is important to you and that you care about how your personal data is used and shared online. # 4. Your Rights

  - 4.1.5 The right to restrict (i.e. prevent) the processing of your personal data;
  - 4.1.6 The right to data portability (obtaining a copy of your personal data to reuse with another service or organisation);
  - 4.1.7 The right to object to Us using your personal data for particular purposes; and
  - 4.1.8 Rights with respect to automated decision making and profiling.

If We are unable to help, you also have the right to lodge a complaint with the UK's supervisory authority, the Information Commissioner's Office.

#### 5. What Data Do We Collect?

- 5.1 We automatically collect the following data as a result of you using Our site:

- 5.2 None of the data described at paras 5.1(a or b) is retained or used for any other purpose than Our Site traffic analysis and We do not pass the data obtained to any other third-party.

  - e) The nature of your enquiry.
- 5.4 None of the data described at paras 5.3(a-e) is passed to any other third-party.

In addition, Google Analytics acts as a Data Processor under Our control to monitor traffic flow through Our Site. However, Google does not provide Us with any data that would allow Us to identify a web user in any way and Google are contractually bound to Us to process data gathered from users of Our Site in accordance with their own privacy policy which may viewed at https://privacy.google.com/businesses/compliance.

### 6. How Do We Use Your Data?

- 6.1 Other than for analytical purposes, data gathered automatically (your IP address and time stamp) is not used by Us for anything more than web traffic analysis and We do not process, retain or store any personal information that is gathered automatically from your use of Our Site.
- 6.2 If you choose to use the email link to contact Us using the email link, we will securely retain the following data for a period not exceeding 3 months unless you continue to enter into correspondence with Us or We are engaged by you for the receipt of any of our advertised services:

We may use your name and email address to contact you for the purposes of addressing your enquiry.
