ONE YEAR LIMITED WARRANTY

Folding Guard (“FG”) is pleased to offer this warranty to the non-retail commercial purchaser of this Folding Guard® Product (“Product”) who either originally purchases the Product directly from FG for commercial use, or originally purchases the Product from an authorized distributor of FG for commercial use (the “Purchaser”). FG warrants to the Purchaser, and not to any other person or entity, that this Product at the time of purchase will be free from defects in workmanship and material caused by FG, subject to the terms and conditions stated in this warranty. This warranty shall apply for a period of one (1) year from the date of purchase of the Product by Purchaser.

The Purchaser acknowledges that Purchaser will be using the Product for commercial applications and not as a consumer product. This warranty applies only to commercial purchases. This warranty is provided only to the Purchaser and is not assignable to any other person or entity. If the Purchaser gives a warranty to its customers, FG shall have no obligation with respect to such warranty. The Purchaser shall be solely responsible for determining whether or not the Product is suitable for use in any particular application.

FG’s sole obligation for breach of this warranty is limited to, at FG’s option and sole discretion, repair or replacement of the defective Product, or a credit equal to the purchase price of the Product. Such repair, replacement, or credit allowance will be the sole and exclusive remedy under this warranty, and will not extend the warranty period or create any new warranty.

This warranty does not apply to, and FG will not be responsible for, damages or issues arising from or related to (i) acts or omissions of any person or entity other than FG; (ii) shipping or handling, (iii) negligence, abuse, misuse, alteration, improper installation or unauthorized repair, or (iv) acts of God or other natural forces, including but not limited to, smoke, fire, flood, tornado, hurricane, earthquake, wind, lightning, any other casualty event, or any damage or event that is covered or ordinarily would be covered by insurance coverage. This warranty is void if Products are not properly installed indoors in a dry environment.

THIS LIMITED WARRANTY, AND THE REMEDIES SPECIFIED HEREIN, ARE IN LIEU OF ALL OTHER WARRANTIES AND REMEDIES, EXPRESS OR IMPLIED. ANY EXPRESS OR IMPLIED WARRANTIES, INCLUDING BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE AND THE EXPRESS WARRANTIES OF MODEL AND SAMPLE, ARE HEREBY DISCLAIMED. IN NO EVENT SHALL FG BE LIABLE FOR SPECIAL, INCIDENTAL, INDIRECT, OR CONSEQUENTIAL DAMAGES, OR FOR REMOVAL, REINSTALLATION, OR TRANSPORTATION COSTS. IN NO EVENT SHALL FG BE LIABLE FOR DAMAGES IN EXCESS OF THE ORIGINAL PURCHASE PRICE OF THE PRODUCT.

No modification of this warranty shall be effective unless it is in writing and signed by an authorized officer of FG. This warranty supersedes all previous warranties, if any.

To take advantage of this warranty, the Purchaser must send timely written notice of any claim, within the warranty period, to FG at the address listed below. The notice must describe the Product and the claimed defect, and must include a copy of the original purchase receipt. Failure to comply with this warranty shall render the warranty null and void.
