

## LOCATION


Glasgow is Scotland largest city with a direct population of 660,000 people and a shopping and leisure catchment of 2,200,000 within a 20 minute drive time.

The subjects benefit from a highly prominent corner position on the north side of St Vincent Street, within the city's Central Business District. St Vincent Street at this juncture is a very busy thoroughfare connecting to the city centre to the east and to the Central Scotland motorway network a very short distance to the west via junctions 18 and 19 of the M8 motorway.

The immediate locale is an established and expanding business location with recent Grade A office developments adjacent. The new Scottish Power HQ has capacity for 2,200 employees, whilst St Vincent Plaza is now home to KPMG, Mott Macdonald, Registers of Scotland, Whyte & Mackay and Wood Group and will house 2,000 employees once fully let. The building of which the subjects form part, will accommodate 700 people once let.

Other major employers in the immediate locale include Santander and DWF LLP.
