The Street Works qualifications in excavation and reinstatement in the highway are derived from two sets of regulations which cover England, Wales and Scotland, made under the New Roads and Street Works Act 1991. (These regulations were introduced in Northern Ireland in 1997.)

There are sixteen units of competence: nine units are for Operatives and eight units for Supervisors. Unit 001 applies to both groups. The achievement of various combinations of units leads to full Street Works qualifications. There are twelve full qualifications, which are listed below together with the units required to achieve them. When a candidate achieves all of the units required for a full qualification, CABWI issues the full qualification certificate automatically. Completion of a full qualification allows the individual to gain a Street Works card via the Street Works Qualifications Register (SWQR).

In 2010, new regulations were introduced in England, requiring any operative or supervisor working in England to be reassessed before renewing their Street Works card through the Street Works Qualifications Register. Candidates may be assessed again in full under the main Street Works scheme, or they may take a knowledge reassessment, which is undertaken using a multiple-choice test for any unit that they wish to renew.

Reassessment unit certificates are issued to candidates who complete the multiple-choice test, and CABWI issues full reassessment qualification certificates are issued automatically for any candidate who completes the correct combination of units to gain a full qualification. The unit and qualification titles mirror those of the main Street Works scheme, and are listed below.
