The church is committed to supporting, resourcing and training those who undertake this work. Each person who works with children and adults at risk will agree to abide by these recommendations and the guidelines established by this church.

• Safer working practices

We are committed to providing an environment that is as safe as possible for everyone and will adopt ways of working with them that promote their safety and well-being.

We are committed to the prevention of any sort of abuse. We will seek to ensure that the behaviour of any individuals who may pose a risk in the community of the church are managed appropriately. We are dedicated to providing pastoral care and support to all.
