Environmental Policy

Since 1973, we have developed an unequalled expertise in the Manufacture & Installation of Fences, Gates & Railings. In 2016 we moved to a state-of-the-art manufacturing facility in Dublin 8 with extensive display and demonstration areas and over 50,000 sq. ft. of yard space where we stock a wide range of Meshes, Palisade, Gates and other products.

Most of our output is installed by our fully qualified crews who are certified for the products and equipment they use. We complete contracts ranging from a few thousand euro to €1.5 million. We currently employ over 40 people in our 3 locations.

As we are a steel manufacturer, we recognise that our production has negative environmental impacts, however, we have an environmental policy in place to reduce our carbon footprint as much as possible. We aim to do this by,

- Ensuring all environmental laws are abided by.
- By measuring our carbon footprint and monitoring our overall environmental performance.
- Continuously improving our environmental performance.
- Minimising the risk of pollution by measuring and monitoring all pollutants.
- We aim to encourage our suppliers and customers to be more environmentally aware by leading by example.

These principles are identified in our commitment to the Ecomerit environmental certification.

From our analysis of our carbon footprint, we have identified that the main environmental impacts arise from the fuel that our vehicle fleet consumes, and the electricity used for heating and lighting. In order to minimise this, we are looking at integrating electric vehicles into our fleet and to also change all lighting to LED lights to cut down on energy consumption.

We now monitor our fuel consumption for all our vehicles to ensure we are tracking our emissions and also measuring our electricity output along with all our waste which is segregated and disposed of in an appropriate manner that complies with environmental laws.

In all our activities, we aim to be an environmentally responsible member of the community we serve.
