

1. ACCOUNTING POLICIES

a) Basis of preparation of financial statements

The financial statements are prepared under the historical cost convention.

b) Turnover

Turnover represents amounts invoiced by the company in respect of goods & services provided during the year, excluding Value Added Tax.

c) Tangible fixed assets and depreciation

Tangible fixed assets are stated at cost less depreciation.
